### LEGAL CONDITIONS FOR USE OF CHILDREN'S PASSPORT

## 1. GENERAL CONCEPT OF "CHILDREN'S PASSPORT"

1.1 The "Children's Passport" is a personal and non-transferable card that, once applied for, will be issued by FUTBOL CLUB BARCELONA (hereinafter FC BARCELONA) to club members that comply with the following demandable requisites: (i) are not older than 14 years at the time the application is made, (ii) do not have a season ticket, and (iii) are up to date with payment of their membership fees. This personal card, provided it is duly activated for each match, will be a sufficient document in order for the cardholding minor to attend matches played by FC BARCELONA at the Camp Nou in line with the conditions laid out below.

- 1.2 The "Children's Passport" is free and provided for Club members of 14 or under, under permitted legal and safety conditions and if the ground capacity allows its use. However, the passport does not imply any further rights for its holder.
- 1.3 The requested "Children's Passport" is personal and non-transferable and is issued for use only and exclusively by the aforesaid child member and this person may only enter the Stadium if accompanied by an adult who is also entitled to enter the stadium (with a ticket or season ticket).
- 1.4 Transfer of the "Children's Passport" is totally forbidden. Breach of this prohibition will imply the consequences detailed in the FUTBOL CLUB BARCELONA Statutes for cases of transfer of season tickets that shall be applied in the same manner to such cases.

## 2. CHILDREN'S PASSPORT APPLICATION PROCEDURE

- 2.1 Applications for the "Children's Passport" must necessarily be made by an adult (over 18 years) who is either the progenitor or legal guardian of the child member aged 8 years or under and who is not a season ticket holder, and who shall be the beneficiary and holder of the "Children's Passport" which is the object of application. Therefore, this operation may only be performed with the knowledge and consent, and at their responsibility, of the adult of the aforesaid status.
- 2.2 Each child member aged 14 years or under may only make one application for a "Children's Passport" per season.



- 2.3 The Passport is valid for one (1) year after it has been granted like the Club's other tickets and passes. However, the passport will be automatically renewed free of charge until (1) eligibility is no longer met, (ii) a formal request is made to give up the passport, (iii) a sanction is applied which means the removal of the passport (iv) the offer is no longer available.
- 2.4 An application for a "Children's Passport" must be made in one of two ways:
  - a) by visiting the Oficina d'Atenció al Barcelonista (OAB) and completing the form at any time during the year.
- 2.5 In case of loss or theft, a duplicate copy must be made at the Barcelona Supporter Services Office, for which the same conditions, requirements and procedures will be applicable as for duplicate season tickets.

#### 3. OPERATION TO ACTIVATE CHILDREN'S PASSPORT MATCH BY MATCH

- 3.1 The "Children's Passport" will arrive in deactivated form. This means that each time the minor wishes to attend a game at the Stadium (provided it is not a match that is excluded from the Children at the Camp Nou project), they must expressly request activation for the match in question by means of the online form or using the APP.
- 3.2 There are two methods for activating the "Children's Passport":
  - ✓ The mobile application (app) available for iOS and Android that can be downloaded from the Club website.
  - ✓ Directly using the online form available on the Club website.
- 3.3 The "Children's Passport" may be activated from six (6) days before the match is played until the end of the game. Effective activation is always subject to the existence of free seats in the sector of the Camp Nou for which the accompanying adult is entitled to entry. Or previously established capacity limits?
- 3.4 There are two methods for requesting activation of the "Children's Passport":
  - a) If the request for activation is made by a season ticket holding member, they must enter their membership code and PIN, followed by those of the child member.
  - b) If the request for activation is made by a non-season ticket holding member or non-member, they must enter the number on the barcode on the ticket purchased for the match for which the "Children's Passport" is to be activated.
- 3.5 On confirmation of the activation of the "Children's Passport", the system will indicate the Stadium gate through which the minor with a "Children's Passport" must enter the ground, which must necessarily be located in the same sector as the seat corresponding to that of the ticket or season ticket belonging to the adult that has undertaken the activation. Both the adult and the minor must enter together through the gate assigned to the minor.
- 3.6 Each adult can enter the Stadium with just one (1) Passport holding child under the conditions and limitations laid out in this document.

The adult who has activated the Passport is obliged to assume the responsibility of accompanying the child in the stadium and taking care of the child during his time at the stadium, expressly exonerating FUTBOL CLUB BARCELONA from any responsibility due to a failure to fulfil this obligation.

- 3.7 Some matches considered to be high-risk are excluded from the Children at the Camp Nou and therefore for these matches it will not be possible to activate the "Children's Passport". These matches are:
  - ✓ Real Madrid and Atlético Madrid in Liga or Cup
  - ✓ UEFA Champions League matches from the second round onwards.
  - ✓ Either leg of the Spanish Supercup.
  - ✓ The Club reserves the exceptional right to declare any other match to be high risk.



a. FC BARCELONA cannot activate the Children's Passport should, on the date of application, there be any arrears in payment of membership fees.

In such a circumstance, the adult responsible for the child will be notified and required to resolve the issue. Should this not happen within 15 days of notification, the Club will begin the process of removing the Passport's validity.

### 4. HOW THE CHILDREN'S PASSPORT WORKS

- 4.1 The "Children's Passport" includes a QR code that, once the request for activation has been made, enables direct entry via the entrance control or turnstile to the Stadium detailed in the confirmation email. The seat will be in the same section of the stadium as the adult season ticket holder who activated the "Children's Passport" for each specific match. Only 1 Passport holding child can accompany the child and the two must enter together.
- 4.2 The adult companion must have a ticket for the match in question, or otherwise a season ticket which has not been provided to the Club for use in the Seient Lliure service.
- 4.3 The applicant adult is under all circumstances the party responsible for the minor holder of the "Children's Passport"; and not only for the operation of activating the same, but also during the operation and use of the "Children's Passport", during entry to the Stadium and for overseeing and looking after the child during the match.
