## LEGAL TERMS AND CONDITIONS FOR THE ALLOCATION OF TICKETS FOR THE FOOTBALL MATCH REAL MADRID - FC BARCELONA FOR THE 9<sup>th</sup> MATCH DAY OF LA LIGA (2022/2023 SPORTS SEASON)

### **1st TERM.- SCOPE.**

FUTBOL CLUB BARCELONA (hereinafter FC BARCELONA or the CLUB), with registered office at Calle Aristides Maillol, s/n, 08028 Barcelona, with Tax Identification Number G-08.266.298, has made available to the group of FC BARCELONA Supporters Clubs (hereinafter, "Supporters' Clubs") the right to request a determined number of tickets to attend the football match REAL MADRID - FC BARCELONA (hereinafter, the "Match"), corresponding to the 9<sup>th</sup> match day of the La Liga Championship, to be played on the 16<sup>th</sup> of October 2022 at the Santiago Bernabéu Stadium (hereinafter, the "Stadium"), except in the event of cancellation or force majeure that prevents it.

The number of tickets available for the Match is in any case subject: (i) to the criteria set by the home club and/or the bodies organising the Match; and (ii) to the safety measures and protocols dictated by the health authorities against exposure to COVID-19, which require reducing the capacity of the stadium where the Match is played. In accordance with the above, FC BARCELONA is not responsible for the unavailability of tickets for the Match. In addition, FC BARCELONA is not responsible for the cancellation of the Match due to force majeure that would force it to be played behind closed doors.

According to the record of applications received by the CLUB, the number of tickets requested exceeds the number of tickets available. Therefore, in order to allocate the right to purchase tickets among all the applicant Supporters' Clubs, a lottery will be held.

The purpose of the drawing will be, or as a prize, to award the applicant Supporters' Clubs the right to acquire up to a maximum of two (2) paid tickets for each of the winning Supporters' Clubs, until the available tickets are sold out.

### **2nd TERM.- PUBLICATION OF THE TERMS AND CONDITIONS.**

The publication of these terms will be made on the FC BARCELONA website for the purpose of informing the supporters' clubs of the mechanism for requesting tickets for the match, participation, the mechanics of ticket allocation and the operation of the drawing.

### **3rd TERM.- MECHANICS OF TICKET ASSIGNMENT AND THE DRAWING.**

The drawing for the allocation of tickets will take place before a Notary Public on the 3<sup>rd</sup> of October 2022, and will be carried out according to the conditions indicated below:

# FC BARCELONA

- a) One (1) file will be created among the Supporters' Clubs that have applied for tickets, which will be numbered in sequential order, according to the time at which they made the registration/application.
- b) The drawing will be carried out by computer using a random combination, resulting in one (1) sequential number from those previously assigned to each entry. This randomly selected number will be the first of the winning Supporters' Clubs, which will be allocated the right to one (1) to two (2) tickets (depending on the number of tickets requested in each case). Next, the Supporters' Clubs with the numbers immediately following the first winning number in sequence will also be awarded prizes, which will also be assigned the right to one (1) to two (2) tickets (as the case may be), until the number of tickets available is exhausted, with the rest of the numbers having the status of reserves.
- c) Once the drawing has taken place, the Notary Public will close the minutes in which the identification of the Supporters' Clubs that have won the maximum number of tickets available will be recorded, by means of the sequential number of the order of inscription.
- d) The winning Supporters' Clubs will be duly informed by the FC BARCELONA staff designated for this purpose, in writing by e-mail to the e-mail address linked to the Supporters' Club that appears in the Club's database. A letter will also be sent by e-mail to those Supporters' Clubs that did not receive a prize.

## **4th TERM.- TICKET PURCHASE PROCEDURE**

FC BARCELONA will have the list containing the names of the Supporters' Clubs that have won and, therefore, have the right to purchase ticket(s). Tickets must be purchased within the deadline established by the FC Barcelona Supporters' Clubs Department after the allocation of the tickets. In the event that any of the winning Supporters' Clubs do not proceed with the purchase within the indicated period, they will lose the right to the purchase of the ticket(s), it being understood that they waive the same. In this case, the tickets will be made available to the first of the "Reserve" Supporters' Clubs, which will be entitled to purchase the tickets within the deadline established by the FC Barcelona Supporters' Clubs Department of notification to such purposes.

The payment of the ticket(s) will be made by the Supporters' Club, and the ticket(s) will be linked in all cases to members of the winning Supporters' Club. The price and location (zone) of the corresponding area to attend the Match shall be as set by the home club at its sole discretion. Payment may only be made by credit card and/or debit card in good credit standing.

Once the amount corresponding to the assigned ticket has been paid, no modifications, refunds and/or cancellations will be accepted.

# FC BARCELONA

At the time of purchase, FC BARCELONA will send an email with the purchase confirmation. The tickets will be nominal and, therefore, the card-carrying member must be the one who uses their ticket.

## **5th TERM.- MISCELLANEOUS.**

- a) Access to the Stadium will be subject to compliance with:
  - The Stadium's own rules.
  - The provisions of any applicable regulations concerning access, safety, health, etc.
  - The provisions of current legislation on violence, racism, xenophobia and intolerance in sport (Law 19/2007 of 11 July and Royal Decree 203/2010 of 26 February).
  - The protocol and health safety measures relating to COVID-19 issued by the relevant authorities and agencies (national and/or international).
- b) The winning participants will have to access the assigned areas in the conditions that the health limitations and regulations allow. However, access to the Stadium may involve security concerns:
  - Inspections.
  - Recordings.
  - Temperature controls.
  - Any other security and/or health measures required in accordance with the established protocols (including the obligation, where applicable, to present the *Covid 19 Digital EU Certificate verification*, the *Vaccination certificate* or the *PCR test certificate* (72hrs.) or *Antigen certificate* test (48hrs.).
- c) The ticket is nominal, personal and non-transferable. Therefore, it must necessarily be used by the purchasing member, who is responsible for its proper use. Consequently, the commercialisation of tickets and/or any other type of transfer or onerous transmission of the same is strictly prohibited, as well as their use for advertising, marketing or promotional purposes (including competitions, gifts and/or draws) and could lead to the automatic cancellation of the same without any type of compensation or refund of the price, in addition to proceeding to notify such conduct to the FC BARCELONA Disciplinary Committee for the purpose of adopting the appropriate measures.
- d) FC BARCELONA informs supporters that the host club and/or the organising body of the match reserve the right to request official documentation containing a photograph and signature of the holder (ID card, NIE, passport, etc.) from those wishing to enter the Stadium. In the event of any anomaly, forgery, counterfeit, imitation, breakage, theft, purchase through resale, or

non-correspondence between the winning fan and the ticket holder, said person will be denied access to the Stadium, and will remain at the disposal (as appropriate) of the Club, the body organising the Match, the personnel designated by the Stadium owner or the competent authorities for this purpose (e.g. private security, security forces and bodies), the ticket will be automatically cancelled, without any type of compensation or refund of the price, in addition to notifying the FC BARCELONA Disciplinary Committee of such conduct so that it can adopt the appropriate measures, and the corresponding authorities so that they can adopt the corresponding administrative, police and/or legal measures.

- e) Supporters must keep the ticket not only for the entire duration of the Match, but also for as long as they remain on the Stadium premises, being obliged to show it to the personnel designated by the host club, the organising body of the Match or the competent authorities for this purpose (e.g. private security, security forces), should they be required to do so.
- f) FC BARCELONA is not responsible for any loss or theft of tickets.

## **6th TERM.- DEPOSIT OF THE BIDDING CONDITIONS BEFORE A NOTARY PUBLIC.**

The terms and conditions of this drawing are deposited with the Notary Public of the Illustrious Association of Notaries of Catalonia.

## **7th TERM.- ACCEPTANCE OF THE RULES AND TERMS AND CONDITIONS OF PURCHASE AND USE OF THE TICKETS.**

Participation in the ticket allocation process implies full acceptance of:

- (i) these terms.
- (ii) knowledge of the mechanics of the allocation and purchase of tickets and of the drawing.

In the event of any discrepancies regarding the ticket application process, the drawing and/or the interpretation of these Terms and Conditions, the Courts and Tribunals of the city of Barcelona will be competent to hear any disputes that may arise, and the participants expressly waive any other jurisdiction that may correspond to them.
