



## LEGAL RULES FOR APPLYING FOR AND PURCHASING FC BARCELONA TICKETS SUPPORTERS' CLUB TRAVEL (2022/2023 SPORTS SEASON)

### RULE 1.-SCOPE.

FUTBOL CLUB BARCELONA (hereinafter, FC BARCELONA or the CLUB), with registered address at calle Arístides Maillol, s/n, 08028 Barcelona, with Tax ID No. G-08.266.298, organises an activity through which it makes available to the collective Supporters' Clubs of FC BARCELONA (hereinafter, the "Supporters' Clubs") the right to request a certain number of tickets (subject in any case to availability criteria) to attend football matches that the FC BARCELONA first team plays as the visiting team in all official competitions during the course of the 2022/23 season. The matches offered, as well as the number of tickets available for each of them, will in any case be subject: (i) to the availability criteria set by the clubs and/or organising bodies of such matches; and (ii) to the criteria established by FC BARCELONA, which may decide, at its sole and exclusive discretion, that the tickets available for a certain match (for reasons of significance or importance) are made available to its supporters' clubs in a way that differs from what is provided in these legal rules, in any case always respecting the Bylaws of the CLUB. In accordance with the above, FC BARCELONA is not responsible for the lack of availability of tickets for a particular match. Additionally, FC BARCELONA is not responsible for the cancellation of the Match due to force majeure.

In order to be able to apply for ticket(s) it will be necessary:

- a) That each supporters' club make the request through the Procedures Portal on the dates indicated by FC BARCELONA for each match.
- b) That the Supporters Club complies with the FC Barcelona Supporters' Clubs Regulations of January 2022 and is registered and ACTIVE in the FC BARCELONA Database.
- c) To make the request under the Terms and Conditions established in the Procedures Portal provided by FC BARCELONA.

The tickets will be assigned by FC BARCELONA among the requesting supporters' clubs, distributing the tickets (depending on demand) in a way that guarantees fairness, with a maximum number of tickets per supporters' club, according to the request made.

In the event that the requests received by the CLUB are for a greater number of tickets than the number of tickets available and a minimum of one (1) ticket per club cannot be assigned, a draw will be held in order to allocate the right to buy tickets among all the requesting Supporters' Clubs.

The purpose of the draw and, in effect, its prize, is to award the requesting Supporters' Clubs the right to acquire up to a maximum of two (2) paid tickets to each of the winners, until the available tickets are exhausted.

# FC BARCELONA

## **RULE 2.- PUBLICATION OF THE RULES.**

These rules will be published on the FC BARCELONA website in order to inform the Supporters' Clubs of the ticket request mechanism for each of the matches, how to participate, ticket allocation mechanisms and how the draw works.

## **RULE 3.- REGISTRATION MECHANISM (CONDITIONAL ON AVAILABILITY)**

The opening of the registration period for the ticket request will vary depending on the match, beginning, in any case, sufficiently in advance of the date of the match in question. The registration's start and end date and time for each match will be published through the official communication channels of the CLUB.

Registration will be made exclusively online through the Supporters' Clubs Procedures Portal. To access the registration form, the authorised person of the Supporters' Club will have to use their credentials.

## **RULE 4.- TICKET ALLOCATION AND DRAW MECHANISM.**

Once the period for ticket request by supporters' clubs closes, a file will be created with all registered registrations/requests, which will be numbered in sequential order, depending on when they are made. An equitable distribution of the tickets will be made automatically among the requesting supporters' clubs, and the names of the attending supporters' club members will be requested, according to the number of tickets assigned for each match, indicating:

- Name and surname of the supporters' club member(s).
- Date of birth of the supporters' club member(s).
- Contact telephone number of the supporters' club making the application.
- National ID Card, Passport, Foreigner ID Card and/or any other official document that proves the identity and details of the supporters' club member receiving each ticket.
- Payment (see rule 5).

The inclusion of the data of the supporters' club members with the right to purchase a ticket must be performed by the authorised people within the supporters' club, through the Procedures Portal provided by FC BARCELONA for this purpose, verifying that the user of the assigned ticket is an official member of the supporters' club. For this purpose, the person in charge of the Supporters' Club must sign a statement of compliance document, stating compliance with data protection regulations in order to transfer to FC BARCELONA the data of the supporters' club members with the right to purchase tickets.

# FC BARCELONA

When an equitable distribution cannot be made guaranteeing a minimum of one (1) ticket assigned per supporters' club, a draw will be held.

The draw for the allocation of tickets will be held before a Notary on the day and time designated by FC BARCELONA, and will be carried out according to the following conditions:

- a) One (1) file will be created among the Supporters' Clubs that have requested tickets, which will be numbered in sequential order, based on when they made the registration/request.
- b) The draw will be carried out electronically by random combination, which will pick one (1) sequential number from those assigned prior to each registration. This number, chosen at random, will represent the first of the chosen Clubs, which will be assigned the right to purchase one (1) or two (2) tickets (depending on the number of tickets requested in each case). Next, the Supporters' Clubs with the numbers immediately after the first number picked will also be chosen, and will also be assigned the right to purchase one (1) or two (2) tickets (as the case may be), until all the available tickets have been exhausted, with the rest of the numbers being "reserves".
- c) Once the draw has been held, the Notary will close the record identifying the Supporters' Clubs that have been picked until reaching the maximum number of available tickets, based on their sequential number in order of registration.
- d) The winning Supporters' Clubs will be duly informed by the FC BARCELONA staff designated for this purpose, by notifying them through the application registered in the Procedures Portal. Clubs NOT picked in the draw will also be notified through the same channel.

## **RULE 5.- TICKET PURCHASE OPERATION**

FC BARCELONA will keep a list containing all the Supporters' Clubs that have been picked in the draw and, therefore, have a recognised right to purchase tickets. The purchase of such tickets must be made within the period indicated by the FC BARCELONA Supporters' Clubs Department, starting from the allocation of the tickets. In the event that any of the picked Supporters' Clubs does not proceed with the purchase within the indicated period, they will lose the right to purchase the ticket(s), it being understood that they waive the ticket(s). In this case, the tickets will be made available to the first of the "reserve" Supporters' Clubs, which will have the right to purchase the tickets within the period established by the Supporters' Clubs Department.

# FC BARCELONA

The payment of the ticket(s) will be made by the Supporters' Club, and the same will be associated with members of the picked Supporters' Club. The price and location (zone) of the corresponding seats to attend the Match will be established by the local club at its sole discretion. Payment can only be made by credit card and/or a solvent debit card.

Once the amount corresponding to the assigned ticket has been paid, no modifications, returns, and/or cancellations will be accepted.

At the time the purchase is made, FC BARCELONA will send an email with the purchase confirmation. The tickets will be in the name of the holder and, therefore, the supporter named on the same will be the one who must make use of it.

## **RULE 6.- TICKET COLLECTION OPERATION**

- a) FC BARCELONA will keep a list of the picked supporters' clubs/members that have correctly completed the ticket purchase process for each match, in accordance with the previous rule.
- b) The tickets are in the name of the holder, personal and non-transferable and, therefore, no assignment document will be accepted. Tickets will be collected in person (in the location and at the times that the CLUB determines for such purposes). Tickets cannot be collected in any other place other than the designated one, nor can they be collected outside the hours set by the CLUB. Purchasing supporters' clubs/members will receive an email with all the information necessary to collect tickets.
- c) To collect the ticket, it will be necessary for the purchasing club member to attend in person with their official identification document (National ID Card, Foreigner ID Card, Passport). Under no circumstances will any ticket be delivered to people other than the designated holders of the same.

When the purchasing supporters' club member is a minor (that is, under 18 years of age), the ticket can only be collected by the minor when accompanied by either of their parents and/or a person of legal age who has been assigned legal guardianship of the minor.

- d) In the event that the purchasing supporters' club member does not collect the ticket in accordance with what is indicated in this rule and in the collection instructions sent by the CLUB, it will be understood that they waive it by not meeting the requirements established by FC BARCELONA for the ticket purchase and collection mechanism, losing the amount of the same, the ticket then being at the disposal of FC BARCELONA so that it can make use of it as it deems appropriate.

## **RULE 7.- MISCELLANEOUS.**

- a) Access to the stadium where the match in question is held (hereinafter, the "Stadium") will be subject to compliance with:
- The rules of the Stadium.
  - The provisions of any applicable regulations regarding access, safety, health, etc.
  - The provisions of the regulations currently in force on violence, racism, xenophobia and intolerance in sport (Law 19/2007 of 11 July and Royal Decree 203/2010 of 26 February).
- b) The chosen supporters' club members will have to access their assigned seats under the conditions permitted by any health limitations and regulations. However, for security reasons, access to the Stadium may entail:
- Inspections.
  - Searches.
- c) The ticket is in the name of the holder, personal and non-transferable. Therefore, it must necessarily be used by the purchasing supporters' club member, who shall be responsible for its proper use. Consequently, the sale of tickets and/or any other type of onerous assignment or transmission of them is strictly prohibited, as well as using them for advertising, marketing or promotional purposes (including contests, gifts and/or prize draws) and could involve the automatic cancellation of the ticket without any type of compensation or refund of the price.
- d) FC BARCELONA informs supporters that the host club and/or the entity organising the match reserve the right to request official documentation from people who intend to enter the Stadium, containing a photograph and signature of the holder, such as to allow their identification. (National ID Card, Foreigner ID Card, Passport, etc.). In the event of detecting any anomaly, falsification, imitation, breakage, obtainment through an unauthorised channel, theft, purchase from ticket scouts, or incompatibility between the chosen supporters' club member and the ticket holder, access to the Stadium will be denied to such person, the ticket then remaining at the disposal (as appropriate) of the club, the organising body of the Match, the personnel designated by the owner of the Stadium or the competent authorities for such purposes (e.g. private security, police forces and bodies), being automatically cancelled, without any type of compensation or refund of the price.

# FC BARCELONA

- e) Supporters' club members must keep the ticket not only during the entire period of time the Match lasts, but while they remain in the Stadium facilities, being obliged to show it to the personnel designated by the host club, the organising body of the Match or the competent authorities to such effect (e.g. private security, police forces and bodies), if required to do so.
- f) FC BARCELONA is not responsible for any loss or theft of tickets.

## **RULE 8.- DEPOSIT OF THE RULES BEFORE A NOTARY.**

These rules are deposited before a Notary of the Illustrious College of Notaries of Catalonia.

## **RULE 9.- ACCEPTANCE OF THE RULES AND THE TERMS AND CONDITIONS OF PURCHASE AND USE OF TICKETS.**

Participation in the ticket allocation process implies full acceptance of:

- (i) these rules.
- (ii) the regulations currently in force regarding violence, racism, xenophobia and intolerance in sport (Law 19/2007 of 11 July and Royal Decree 203/2010 of 26 February) to attend the corresponding match.
- (iii) knowledge of the mechanism for requesting and buying tickets and, where appropriate, the draw.
- (iv) the use and processing of personal data in the terms established in these rules.

In case of discrepancies regarding the ticket application process, the draw and/or interpretation of these Rules, the Courts and Tribunals of the city of Barcelona will be competent to hear disputes that may arise, the participants in the same expressly waiving any other jurisdiction that may correspond to them.

## **RULE 11.- COMMUNICATIONS OF THE TICKET APPLICATION PROCESS AND THE DRAW.**

The communications related to the ticket request process and the draw for each match will be described on the website [www.fcbarcelona.com/en](http://www.fcbarcelona.com/en). Interested parties will receive the communications via e-mail, at the e-mail address that they have provided in the participation form or that is recorded in the FC BARCELONA database.
