



LEGAL TERMS AND CONDITIONS "SUPPORTERS' EXPERIENCE SWEEPSTAKES" (2022/2023 sports season)

1st TERM AND CONDITION. SCOPE.

The FUTBOL CLUB BARCELONA, domiciled at calle Arístides Maillol, s/n, 08028, Barcelona, and with NIF number G-08.266.298 (hereinafter, FC BARCELONA or the Club) organises an activity called "Supporters' Experience Sweepstakes" (hereinafter, "the Activity") aimed at the group of people who duly register as a Penyista of FC Barcelona (hereinafter, "Supporter") through the form authorised for such purposes.

The way to participate in the Activity and its mechanics will be communicated and promoted, among the other FC BARCELONA media, on its official website (www.fcbarcelona.es, Infopeñas section), on the supporters' website (<https://penyes.fcbarcelona.com/ca/>) and on the FC BARCELONA social networks.

A sweepstakes will be entered into by one of the entrants and will result in SIX (6) winning persons, each of whom will receive one of the prizes listed in Term and Condition 6.

For the above purposes, in the case the Supporter is a minor, their participation in each and every one of the corresponding phases described in these Terms and Conditions (acceptance of the Terms and Conditions, participation requirements, the workings of the Activity, acceptance of the prize, etc.) must always be supervised and carried out by the person representing them and has their legal custody (father, mother, legal guardian, etc.). So, in accordance with the above, FC BARCELONA understands that the corresponding consents and authorisations are mandatory (acceptance of the Terms and Conditions, participation requirements, acceptance of the award, processing of personal data, litigation, etc.) will be deemed to have been made for all purposes and without reservation by the persons exercising their representation, protection and legal protection, on their behalf, and FC BARCELONA will be exempt from any liability in this regard.

The geographic scope of the Activity is everyone.

2nd TERM AND CONDITION.- PARTICIPATION PERIOD AND PUBLICATION OF THE TERMS AND CONDITIONS.

The period of participation in the Activity will coincide with the period authorised for registration as a FC BARCELONA Supporter. Therefore, it will begin on 7 March 2023, and end on 30 April of the same year.

3rd.- TERM AND CONDITION - AUTHORISATION TO USE PERSONAL DATA.

a) DATA CONTROLLER: Your personal data will be processed by FC BARCELONA, domiciled at calle Aristides Maillol s/n, 08028, Barcelona and with Tax ID No G-08266298.

b) PURPOSES, LEGAL BASIS, AND CONSERVATION PERIOD: The data will be processed for the following purposes:

Participation in the Activity	Your personal data will be processed to manage participation in the Activity, as well as to carry out all the procedures provided for in these legal bases.	Contractual relationship and legal obligation The information we may have in relation to participation in this Activity will be processed until the end of this Activity and, in the event of winning, your personal data will be processed for a period of one year, or until you object to the processing.
Winning Prize Submission	The winners' details will be processed in order to submit the prize. In any case, if the person participating is a minor, the data of the adults responsible for this will be processed. FC BARCELONA reserves the right to contact you if necessary.	Consent Your data will be processed until you withdraw your consent.

c) COMMUNICATION OF DATA: Your data will not be transferred, sold, rented, or otherwise made available to any third party, with the exception of those FC BARCELONA service suppliers that perform certain activities for the Club, but who will in no case process the data for their own purposes. Some of these suppliers may be outside the European Union, as indicated below.

d) INTERNATIONAL TRANSFERS: FC BARCELONA, as an entity with international scope, has international suppliers that may provide their services from outside the EU, so it is possible that your data may be processed outside the European Union or the European Economic Area (e.g. data storage, management of information requests or club member services, etc.).

In any case, the Club will ensure that said data processing is always protected with the appropriate guarantees, which may include:

- EU-approved Standard Clauses.
- Third-party certifications.

e) DURATION OF PROCESSING: All the data you provide to us will be processed in accordance with that indicated in section b) above.

Following the indicated period, FC BARCELONA will keep your data duly anonymised for statistical or market research purposes, whenever possible, or duly blocked to comply with any legal CLUB obligation.

f) EXERCISING YOUR RIGHTS:

In the event that a response is not obtained within a reasonable period, a claim may be filed with the Spanish Data Protection Authority.

g) CONSENT FOR THE PROCESSING OF DATA OF MINORS:

The legal representation for the minor authorising their participation in the Activity, if sharing the rights and responsibilities for the minor with another person, warrants that they have received proper consent and therefore subscribes on behalf of all of the minor's responsible individuals. In this regard, FC BARCELONA reserves the right to contact all of them to secure any other information that is necessary to verify this or any other that is necessary.

4th TERM AND CONDITION.- REQUIREMENTS AND WORKINGS OF PARTICIPATION.

All those interested in participating in the Activity must meet the requirements detailed below:

- Register as a FC BARCELONA Supporter, duly filling out the participation form enabled on the Club website.
- Accept these legal bases.

5th TERM AND CONDITION.- WORKINGS OF THE SWEEPSTAKES.

a) In the event that nobody participates, it will not be necessary to hold the sweepstakes, which is declared automatically cancelled.

b) In the event that only six (6) or fewer persons participate in the Activity, the drawing will not be necessary, and these persons will automatically have the status of winners. Therefore, these individuals will be awarded the prize directly by strict search order, and without the need for a sweepstakes. Individuals who have not successfully registered for the Activity and do not meet the entry requirements of the 4th Term and Condition will not be entered into the sweepstakes.

c) The participants will be assigned a sequential number according to the chronological order of participation, in order to have a consecutive range of numbers (e.g., from 1 to 50).

d) The sweepstakes drawing will be conducted using a computer system that, based on a random combination, will randomly choose twenty-six (26) numbers. The first six (6) will have the status of “winner” and the remaining twenty (20) will have the status of “waiting list”.

e) The sweepstakes will be held before a notary public, on 2 May 2023.

f) Once the sweepstakes has been held, the Notary Public will close the minutes in which the identification of the persons (sweepstakes drawing number) who have been successful will be recorded, maintaining the order that has been the result of the draw. Thus, the first person to be a winner will be identified as a “first winner” and so forth. The remaining twenty (20) persons will have the status of “waiting list”, also in the order of the results.

g) The winners will obtain one of the prizes in a correlative manner, that is, the first winner will obtain the first prize, the second winner will obtain the second prize, and so on until reaching the sixth winner, who will obtain the sixth prize, in accordance with what is indicated in Term and Condition 6.

g) The results of the sweepstakes will be communicated to the winning participant via email contact provided for the purposes of participating in the Activity, as well as the information related to the logistics for collecting the prize.

h) With participation in this Activity, individuals of legal age who do participate and, for minors, individuals of legal age, EXPRESSLY ACCEPT (i) these terms and conditions and, (ii) that in the event that you are the winner of the Activity, you will receive an email sent by FC BARCELONA to the email address provided by FC BARCELONA, that will serve as a means of proof, for all purposes, of the communication made by FC BARCELONA, reporting about this condition. In the event that contact with the winning participant is not possible within a forty-eight hours (48 hour) period, from the time that the first communication occurs, for any reason or circumstance beyond the control of the Club, this individual will lose their right to the prize, which will then be awarded to the first person on the waiting list, and so on.

7th TERM AND CONDITION.- ACCEPTANCE OF THE PRIZE.

7.1. Tickets to the match are for personal use and non-transferable.

7.2. Therefore, the winning participants (and in the case of minors, their legal representatives), once informed of their status as the winner, must give a specific response by email, prior to delivery and, where appropriate, receipt of the prize in question, indicating (i) their acceptance or (ii) their waiver of the prize that they have been awarded.

Considering the above, if:

a) They are accepted, they must indicate whether they will attend the match alone or with a companion in the terms established in these terms and conditions, with it being necessary for them to sign a document that will contain the express acceptance of the prize and the receipt thereof in accordance, declaring that they have nothing to claim or demand from FC BARCELONA, agreeing to strictly comply with the indications and/or instructions established by FC BARCELONA to access the facilities on the day of the match.
