



LEGAL BASES LIGA F VICTORY T-SHIRT DRAW FOR SUPPORTERS (Sports season: 2022/2023)

BASIS no.1. SCOPE.

BARCELONA FOOTBALL CLUB, registered address: Calle Aristides Maillol, s/n, 08028, Barcelona, holding national tax [NIF] number G-08.266.298 (hereinafter, FC BARCELONA or the Club) is due to organize an activity known as the "Liga F Victory shirt raffle for Supporters" (hereinafter "the Activity"), which is intended for the cohort of persons duly registered as Supporters of FC BARCELONA (hereinafter a "Supporter") using the form provided for such purposes.

Information on the means of participation in the Activity and on its functioning will be shared and promoted through FC BARCELONA media, on its official website (www.fcbarcelona.en), on the general site for supporters (<https://penyes.fcbarcelona.com/en/>), on Infopeñas, and on FC BARCELONA's social networks.

A draw will be held among those registered as a FC Barcelona Supporters' Club Member until the 25th of October at 7pm CET. A total of FIFTY (50) winners will be awarded with the prize stated on Basis no. 6

For the above purposes, in the event the Supporter Club Member is a minor, their participation in each and every one of the corresponding phases described in these Clauses (acceptance of the Clauses, participation requirements, procedure of the draw, acceptance of the prize, etc.) must always and in all cases be supervised by the person exercising their rights of representation and legal guardianship (father, mother, legal guardian, etc.). Therefore, in accordance with the above, FC BARCELONA understands that the corresponding mandatory consents and authorizations (acceptance of the Clauses, requirements for participation, acceptance of the prize, collection and processing of personal data, litigation, etc.) will be deemed to have been granted for all purposes and without reservations by the people who exercise their representation, legal protection and guardianship, in their name, and FC BARCELONA will be exempt from any responsibility in this regard.

The Activity shall take place worldwide.

BASIS no.2.- PARTICIPATION PERIOD AND PUBLICATION OF THE LEGAL BASES.

All FC Barcelona Supporters' Clubs Members registered before the 25th of October at 7pm CET will automatically enter the draw.

BASIS no.3.- AUTHORISATION RELATING TO THE USE OF PERSONAL DATA.

- a) DATA CONTROLLER: Your personal data will be processed by FC BARCELONA, registered address: Calle Arístides Maillol, s/n, 08028 Barcelona, holding tax identification number [NIF] G-08266298.
- b) PURPOSES, BASES FOR LEGITIMACY AND CONSERVATION PERIOD: Data will be processed for the following purposes:

Participation in the Activity	Your personal data will be processed to manage participation in the Activity, as well as to carry out all the procedures set out in these legal bases.	Contractual relationship and legal obligation Any information which we might hold relating to your participation in this Activity will be processed until the end of this Activity and in the event that you should be a winner, your personal data will be processed for a period of one year, or until you object to the processing of your data.
Shipping of a winner's prize	Winners' data will be processed in order for a prize to be sent. In any case, if the person participating is a minor, the data belonging to the responsible adults will be processed. FC BARCELONA reserves the right to make contact where necessary.	Consent Your data will be processed until you withdraw your consent.

- c) SHARING OF DATA: Your data will not be transferred, sold, leased or otherwise made available to any third party other than FC BARCELONA service providers performing certain activities for the Club. However, the latter will under no circumstances process the data for their own purposes. Some of these providers may be located outside the European Union, as specified below.
- d) INTERNATIONAL TRANSFERS: FC BARCELONA, as an organization with international exposure, uses international providers which may provide their services from outside the EU, therefore it is possible that your data may be processed outside the European Union or the European Economic Area (e.g. data storage, handling of requests for information, member customer care, etc.).

In any case, the Club will ensure that this data processing is always protected using appropriate guarantees, which may include:

- Standard Clauses approved by the EU
- Third-party certifications

e) **DURATION OF PROCESSING:** Any and all data you provide to us will be treated in accordance with the provisions of section b) above.

At the end of the period specified, FC BARCELONA will store your data on a duly anonymised basis for statistical or market research purposes, whenever possible, or on a duly restricted basis, to comply with any legal obligation held by the Club.

f) **EXERCISING YOUR RIGHTS:**

If you do not receive a response within a reasonable time frame, you may file a complaint with the Spanish Data Protection Authority.

g) **CONSENT RELATING TO THE PROCESSING OF DATA BELONGING TO MINORS:**

A legal representative for a minor person, who is authorising their participation in the Activity, and sharing their duties and responsibilities in respect of the minor person with another person, will guarantee that they have obtained the appropriate consent and that, therefore, they are signing on behalf of all persons responsible for the minor. In this regard, FC BARCELONA reserves the right to contact all said persons to obtain any further information which may be necessary to verify such consent, or any other matter, as necessary.

BASIS no.4.- REQUIREMENTS AND HOW TO PARTICIPATE.

Any persons interested in participating in the Activity must meet the requirements set out below:

- Being registered as FC Barcelona Supporters' Clubs Member on or before the 25th of October 2023 at 7pm CET
- Accept these legal bases.

BASIS no.5. DRAW MECHANISM.

a) A draw is to take place among those registered as FC Barcelona Supporters' Clubs Members on or before the 25th of October 2023 at 7pm CET.

- b) The draw will be made through a computer system that, from a random combination, will choose sixty (60) random numbers. The first fifty (50) be the “winners” and the remaining ten (10) will be “replacements”.
- c) The draw is to be held before a notary on the 3rd of November 2023.
- d) Once the draw has been held, the Notary Public will finalize the minutes recording the identification of persons (per draw numbers) who are winners, as well as the identification of the reserve persons.
- e) The result of the draw will be shared with the winning persons by way of emails sent to the email addresses provided by said persons to register as Supporters and participate in the Activity, as will information relating to the logistics for the delivery or shipping of the prize.
- f) In taking part in this Activity, the persons of legal age who take part and, in the case of minors, persons of legal age who hold or have been assigned as their legal guardian, EXPRESSLY ACCEPT (i) these legal bases and, (ii) that in the event of their winning the Activity, they will receive an email sent by FC BARCELONA to the email address provided, which will serve as a means of proof, in general, of communication made by FC BARCELONA, notifying them that they have won. Such contact will be made during the week after the draw is held. If a winner cannot be contacted within forty-eight hours (48 hours) following the time contact was first attempted, for any reason or circumstance not attributable to the Club, this winner will lose his/her right to the prize, which will then be awarded to the first reserve person, and so on.
- g) Any person winning the prize must accept it, or, in the case of a minor, the prize will be accepted by the minor’s legal representatives, who must declare that they accept or decline the prize. In the first case, the Club’s instructions on the logistics of delivery and on collecting the prize, where appropriate, must be closely followed.

BASIS no.6. PRIZE.

Each winning person will receive the following prize:

- A “Liga F Victory 2023” shirt from the FC BARCELONA Men’s Football Team.

The prize will not in any event include an item other than the one described above, nor may it be substituted for its cash value.

BASIS no.7.- ACCEPTANCE OF THE PRIZE.

Once they have been informed that they have won, the winning person (and in the case of a minor, the persons who are their legal representatives) must send an express response by email, prior to the delivery and, where appropriate, prior to receiving the prize in question, indicating (i) whether they accept or (ii) whether they decline the prize they have been awarded, because:

- a) If the winning person accepts, it will be possible for a prize to be sent, subject to the conditions specified by the Club to the winning person, signing a document setting out the express

acceptance of the prize pertaining to the winner and the receipt thereof, in good order, the winner stating that they have no claim nor demand to lodge with FC BARCELONA.

Should the winning person not be of age, the persons who are their legal representatives must accept the prize on their behalf, subject to the terms and conditions set out in the previous paragraph.

In the event that they accept, the winning person of legal age or the legal representative, in the case of minors, must provide their name, last name, telephone number and postal address.

- b) In the event of their declining the prize, this must be stated in writing. In this case, the Club will state that the aforementioned prize cannot be exchanged for another prize nor for its cash value, and the first person on the reserve list will automatically become a winner, and will at that time be awarded the aforementioned prize, following the same procedure, and so on.

BASIS no.8. DEPOSITING OF THE LEGAL BASES BEFORE A NOTARY.

These legal bases are to be deposited before a Notary of the Illustrious College of Notaries of Catalonia.

BASIS no.9. ACCEPTANCE OF THE LEGAL BASES.

Participation in this Activity implies express and full acceptance, without reservation, of the following:

- a) These legal bases.
- b) The means of participation and the draw.
- c) The use and processing of personal data according to the terms established in these legal bases.

Should there be any discrepancy regarding the Activity and/or the interpretation of these legal bases, the Courts and Tribunals of the city of Barcelona will be competent to hear any disputes which may arise, the participants in this Activity expressly waiving any other jurisdiction with which they may have a recourse.

In the case of minors participating in the Activity, they will always do so with the written consent of the persons who are their guardians and have custody over them.

BASIS no.10. COMMUNICATION RELATING TO THE ACTIVITY.
