BASE 1. AMBIT.

FÚTBOL CLUB BARCELONA, domiciled at Calle Arístides Maillol, s/n, 08028, Barcelona, and with CIF number G-08.266.298 (hereinafter, FC BARCELONA or the CLUB) organizes an Action called "VITOR ROQUE 23/24 T-Shirt GIVEAWAY" (hereinafter the "Action") aimed at those people who complete the registration process as Culer (or are already registered) and agree to participate in this draw under the terms and conditions established in these rules.

The mechanics of participation and operation of the Action will be communicated and promoted, among other communication assets of FC BARCELONA, on its official website (www.fcbarcelona.es), on its social networks and on third-party payment channels.

One (1) winner will be selected from among the people who participate, through the draw described in Rule 5. This person will receive the award in accordance with Rule 6.

certain Actions for the CLUB, but who in no case will process the data for their own purposes. Some of these providers may be located outside the European Union, as indicated below.

g) CONSENT TO THE PROCESSING OF CHILDREN'S DATA:

Whoever holds the legal representation of the minor, who authorizes his/her participation in the Action, in the event of sharing the duties and responsibilities with respect to the minor with another person, guarantees that he/she has obtained the appropriate consent and that, therefore, he/she signs on behalf of all the persons responsible for the minor. All those interested in participating in the Action, regardless of their status as members of FC BARCELONA, must meet the requirements detailed below:

- a) Register as a Culer, if not already registered.
- b) Register the participation in the raffle with the email address registered in "CULERS", by registering in the form provided for this purpose. Each user registered as a Culer may make a single registration. Any duplication will be controlled by a computer security system, so that any additional registrations that may be made by the same user will be cancelled.

RULE 5.- MECHANICS OF THE DRAW.

- a) In the event that no one participates, it will not be necessary to hold the draw, which will be automatically declared cancelled.
- b) In the event that only one (1) person participates in the Action, it will not be necessary to carry out the draw, in order to automatically have the status of winner. Therefore, this person will be awarded the prize directly, without the need for a lottery. informing about this condition. This contact will take place on the same day of the draw.
