



LEGAL BASES

"BEST GOAL OF THE SEASON DRAW" (-Sports Season 2023/2024-)

BASE 1. AMBIT.

FÚTBOL CLUB BARCELONA, domiciled at Calle Aristides Maillol, s/n, 08028, Barcelona, and with CIF number G-08.266.298 (hereinafter, FC BARCELONA or the CLUB) organises an Action called "BEST GOAL OF THE SEASON DRAW" (hereinafter the "Action") aimed solely and exclusively at those people who register or are registered on the "Culers" platform. agree to receive commercial information about FC BARCELONA products and/or its related entities (merchandising, ticketing, digital products, etc.) and to participate in accordance with these rules.

One (1) winner will be chosen from among the people who participate, through the draw described in Rule 4. This person will receive as a prize 2 shirts for the 2023/2024 season and 1 double ticket for the first match of the 2024/2025 season at the Lluís Companys stadium in Montjuïc in accordance with the 5th Base.

The giveaway is available on the territory of all over the world.

For the above purposes, in the event that the participant is a minor, his/her participation in each and every one of the corresponding phases described in these Terms and Conditions (acceptance of the Terms and Conditions, registration and participation requirements, mechanics of the Action, acceptance of the prize, etc.) must always and in all cases be supervised by the person exercising his/her rights of representation or legal guardianship (parent, mother, legal guardian, etc.). Therefore, according to the above, the corresponding and mandatory consents and authorisations will be understood to have been made for all purposes and without reservations by the persons who have their representation, guardianship or legal guardianship, on their behalf, exempting FC BARCELONA from any liability for this cause.

RULE 2.- PARTICIPATION PERIOD

The participation period for the Action will begin on June 3 and will end on June 10.

RULE 3a.- REQUIREMENTS AND MECHANICS OF PARTICIPATION.

3.1. All persons interested in participating in the Action must meet the following requirements:

- 1º) Complete the registration in the "Culers" community, in case you are not already a member.
- 2º) Agree to receive commercial information from FC BARCELONA and/or related entities
- 3º) Participate in the raffle.

3.2. All persons who meet the characteristics mentioned above and, in the case of minors, who do so under the supervision of the adult who represents them, may participate in the Action.

RULE 4.- MECHANICS OF THE DRAW.

4.1. In the event that no one participates, it will not be necessary to hold the draw, which will be automatically declared cancelled.

In the event that only one (1) person participates, it will not be necessary to carry out the raffle, in order to automatically acquire the status of winner. Therefore, you will be awarded the prize directly, without the need for a lottery. Otherwise, it will be necessary to carry out a raffle, only among the persons who have correctly registered in the Action subject of these rules ("Participants"), from among which one (1) winner will be the winner. Therefore, persons who do not meet the requirements of the Action will be excluded from the draw.

4.2. Participants will be assigned a sequential number according to the chronological order of participation, in order to have a consecutive range of numbers (e.g. from 1 to 50).

4.3. Once the participation period has expired, the draw will be carried out through a computer system randomly before a Notary, who will randomly choose one (1) winner and four (4) reserves.

4.4. The draw will take place before a notary on June 11

4.5. Once the draw has been held, the Notary will close the minutes in which the identification of the person who has been the winner, as well as the identification of the reserve persons, will be recorded, in the established order of priority.

4.6. In the event that the winner renounces the prize or does not comply with the requirements established in these terms and conditions, the first person on the reserve list will become the winner, and so on.

4.7. By participating in this Action, the persons of legal age who participate and, in the case of minors, the persons of legal age who have their representation **EXPRESSLY ACCEPT** (i) these rules and, (ii) that in the event of winning the Action, they will receive an email, which will serve as a means of proof, for all intents and purposes, of the communication made by FC BARCELONA, informing about this condition. This contact will take place on the same day of the draw. If it is not possible to contact the winner within twenty-four hours (24 hours) from the moment of the first communication, for any reason or circumstance beyond the control of the CLUB, this person will lose their right to the prize, which will then be awarded to the first person on the reserve list and so on.

4.8. Whoever wins the prize must accept it, or in case of being a minor, it will be accepted by the people who have their legal representation and must declare their acceptance or

renunciation of the prize. In the first case, the instructions provided by FC BARCELONA regarding delivery logistics must be strictly followed.

BASE 5. PRIZE.

The winner of the raffle will receive the following prizes:

- Two (2) home kit shirts for the 2023/2024 season and a double ticket for the first official match of the 2024/2025 sports season that the Club's first football team plays at the Lluís Companys stadium in Montjuïc.

The day and time of the match, as well as the opponent of FC Barcelona will be defined according to the competition schedule.

In the event that the winner is a minor, he/she must attend the match accompanied by a person of legal age that must be indicated at the time of acceptance of the prize.

In the event of waiver or non-acceptance of the prize, the winner must state this in writing. In this case, FC BARCELONA declares that the aforementioned prize may not be exchanged under any circumstances for another product, nor for its cash value, and the status of winner will be transferred to the corresponding reserve.

The prize will not include travel to the Lluís Companys stadium in Montjuïc or any other expense that the winner has to incur to collect the prize. Therefore, under no circumstances will per diems and/or travel expenses be paid for the travel of the winner or, if applicable, during their stay in Barcelona.

RULE 6.- ACCEPTANCE OF THE PRIZE.

The winner (and in the case of being a minor, the persons who have their legal representation), once informed of their status as winner, **must give an express response by email**, prior to the delivery of the prize in question, indicating (i) their acceptance or (ii) their renunciation of the prize, in order to:

- a) In the event of acceptance, FC Barcelona may send the prize to the e-mail address and/or postal address indicated, as appropriate.
At the same time, you will send by e-mail a document containing **the express acceptance** of the prize that corresponds to you and its receipt with conformity, declaring that you have nothing to claim or demand from FC BARCELONA.

If the winner has not reached the age of majority, the persons who have their legal representation must accept the prize on their behalf, subject to the terms and conditions detailed in the previous paragraph.

- Indicate your name, surname, telephone number and postal address.
 - Indicate the name and surname of the person you designate as a companion. If the winner is a minor, the person designated as a companion must be of legal age.
- b) In the event of **resignation or non-acceptance of the prize**, when you receive the email you must **state it in writing**.  - b. The provisions of any applicable regulations on access, safety, health, etc.

- b) The double ticket that makes up the prize subject matter of these terms and conditions is personal and non-transferable. Therefore, it must necessarily be used by the winner and the companion designated by him/her, each of them being responsible for its proper use. The commercialization of tickets and/or any other type of transfer or transfer for consideration is strictly prohibited, as well as the use of them for advertising, marketing or promotional purposes (including competitions, gifts and/or sweepstakes), which could lead to their automatic cancellation without any compensation.

g) **CONSENT TO THE PROCESSING OF CHILDREN'S DATA:**

Whoever has the legal representation of the minor, who authorizes his/her participation in the Action, in the event of sharing the duties and responsibilities with respect to the minor with another person, guarantees that he/she has obtained the appropriate consent and that, therefore, he/she signs on behalf of all the persons responsible for the minor. RULE 9a. DEPOSIT OF THE TERMS AND CONDITIONS BEFORE A NOTARY.

The terms and conditions of this Action shall be deposited with the Notary Public of the Illustrious Association of Notaries of Catalonia.

RULE 10a. ACCEPTANCE OF THE RULES.

Participation in this Action implies the express and full acceptance without reservation of:
