"T-SHIRT AND ED CONCERT"
(-Sports season 2025/2026-)

BASE 1. AMBIT.

FÚTBOL CLUB BARCELONA, domiciled at Calle Aristides Maillol, s/n, 08028, Barcelona, and with CIF number G-08.266.298 (hereinafter, FC BARCELONA or the CLUB) organises an Action called "T-SHIRT AND ED CONCERT" (hereinafter the "Action") aimed solely and exclusively at those people who (i) are of legal age, (ii) register or are registered on the "Culers" platform, (iii) agree to receive commercial information about FC BARCELONA products and/or its related entities (merchandising, ticketing, digital products, etc.) and (iv) participate in accordance with these rules.

From among the people who participate, one (1) winner will be chosen, through the draw described in Rule 4. This person will receive as a prize "One (1) T-shirt from the FC Barcelona x Spotify collaboration with Ed Sheeran and two tickets for a concert by the artist, as well as transport and accommodation to attend for two people, if necessary". The details and conditions of the prize are specified in Base 5 and following.

The draw is available on the territory of the whole world.

BASE 2.- PARTICIPATION PERIOD

The period of participation in the Action will begin on October 20th, 2025 and end on November 3rd, 2025.

BASIS 3.- REQUIREMENTS AND MECHANICS OF PARTICIPATION.

3.1. All those interested in participating in the Action must meet the requirements detailed below:

- 1) To be of legal age;
- 2º) Complete the registration in the "Culers" community, in case you are not part of it yet.
- 3) Agree to receive commercial information from FC BARCELONA and/or related entities
- 4) Participate in the draw through the form provided.

3.2. All those persons who meet the characteristics mentioned above may participate in the Action.

BASE 4.- MECHANICS OF THE DRAW.

4.1. In the event that no one participates, it will not be necessary to hold the draw, which will be automatically cancelled.

4.2. In the event that only one (1) person participates, it will not be necessary to carry out the draw, as they will automatically receive the status of winner. Therefore, the prize will be awarded to you directly, without the need for a draw. Otherwise, it will be necessary to carry out a raffle, only among the people who have correctly registered in the Action object of these rules ("Participants"), among which one (1) winner will be awarded. Therefore, people who do not meet the requirements of the Action will be excluded from the draw.

4.3. Participants will be assigned a sequential number according to the chronological order of participation, in order to have a consecutive range of numbers (e.g. from 1 to 50).

4.4. Once the participation period has ended, the draw will be carried out by a computer system randomly before a Notary, who will randomly choose one (1) winner and nine (9) reserve candidates.

4.5. The draw will be held before a notary, on October 28, 2025.

4.6. Once the draw has been held, the Notary will close the minutes in which the identification of the person who has been the winner will be recorded, as well as the identification of the reserve persons, with the established order of priority.

4.7. In the event that the winner renounces the prize or does not comply with the requirements established in these legal bases, the first person on the reserve list will be the winner, and so on.

4.8. By participating in this Action, the persons of legal age who participate **EXPRESSLY ACCEPT** (i) these rules and, (ii) that in the event of winning the Action, they will receive an email, which will serve as evidence, for all purposes, of the communication made by FC BARCELONA, informing them of this condition. This contact will take place on the same day as the draw. In the event that it is not possible to contact the winner within forty-eight hours (48 hours), counting from the moment the first communication is made, for any reason or circumstance beyond the control of the CLUB, this person will lose their right to the prize, which will then be awarded to the first person on the reserve list and so on.

4.9. Whoever wins the prize must accept it, and must declare their acceptance or renunciation of the prize. In the first case, the instructions provided by FC BARCELONA regarding the delivery logistics must be strictly followed.

BASE 5. PRIZE.

The winner of the draw will receive as a prize:

- a) One (1) t-shirt from the collaboration between FC Barcelona and Spotify with Ed Sheeran.
- b) Two (2) tickets (for the winner and the guest) to attend a concert by the artist in Los Angeles at SoFi Stadium on August 8, 2026.

- c) Plane ticket, train or other means of transport to and from the city where the concert takes place, by the winner and the companion. Details on dates and itinerary will be decided exclusively by FC BARCELONA.*
- d) Accommodation for two (2) people (for the winner and the companion), for a maximum of two nights, in the city where the concert takes place.*

*Transportation and accommodation will only be booked if necessary, taking into account the residence of the winner.

The prize will not include any other expenses that the winner may incur during the enjoyment of the prize. Therefore, in no case will subsistence allowances and/or other expenses be paid for the transfer of the winner and the companion, beyond those described here.

Depending on the origin of the winner and the destination (location of the concert), it may be required to process VISAT and/or other similar permits before the corresponding authorities: if this is the case, both its processing and its cost will be borne by and under the exclusive responsibility of the winner.

In the event of resignation or non-acceptance of the prize, the winner must state this in writing. In this case, FC BARCELONA states that the aforementioned prize cannot be exchanged in any case for another product, or for its cash value, and the status of winner will be transferred to the corresponding reserve.

Prizes with a value greater than €300 will be subject to withholding or payment on account of Personal Income Tax (IRPF) or, as appropriate, Non-Resident Income Tax (IRNR), which will be made by FC BARCELONA which will bear the amount of the same. In the event that the beneficiary has the status of non-tax resident in Spain, FC BARCELONA may require a certificate of tax residence in accordance with the corresponding Double Taxation Agreement signed between Spain and the country where the beneficiary is resident. Likewise, in due course, FC BARCELONA will issue the appropriate certification that facilitates the winning participant's compliance with their tax obligations.

In relation to the obligations and tax declarations derived from the prize, each of the parties involved and under their strict responsibility, will be responsible for those that legally correspond to them. Failure to comply with the tax obligations arising from obtaining the prize may have legal consequences for the beneficiary.

BASE 6. TICKETS SUBJECT TO THE PRIZE.

The use of the tickets that make up the prize will be made in accordance with the following conditions:

- a) Access to the concert will be subject to compliance with:
 - a. The rules of the venue where the concert takes place.

- b. The provisions of any applicable regulations on access, safety, health, etc.
 - c. Actions that, for security reasons, may entail access to the premises, such as inspections, searches, etc.
- b) The two tickets that make up the prize subject to these legal bases are personal and non-transferable. Therefore, they must necessarily be used by the winner and the companion they designate, each of them being responsible for their proper use. The marketing of tickets and/or any other type of transfer or transfer of the same for consideration is strictly prohibited, as well as using them for advertising, marketing or promotional purposes (including contests, gifts and/or raffles), which could lead to the automatic cancellation of the same without any type of compensation.
- c) FC BARCELONA is responsible for the loss or theft of the tickets that are the object of the prize and, therefore, will not issue any duplicates.

BASE 7.- TRANSPORT.

Plane, train or other round-trip transport tickets to travel to the city where the concert takes place, by the winner and the companion, which make up this prize only if necessary, taking into account the winner's place of residence and the location of the concert, They will be used in accordance with the following specificities:

- a) The airport, station or other point of origin of the tickets will depend on the winner and the companion, but in any case they will have the same origin. Itinerary details will be at the discretion of FC BARCELONA. The itinerary will be round trip to the same city of origin.
- b) The date and time of the flight will be as stated on the ticket, and the passenger will be responsible for arriving at the airport with the necessary advance notice established by each airport and authority, exempting FC BARCELONA from all liability.
- c) Tickets will not include additional services.
- d) The tickets, if applicable, will be made out to the name of the winner and their companion.
- e) FC BARCELONA is not responsible for any delay, cancellation or other circumstance that affects the schedule of flights.
- f) Each passenger will be responsible for having the necessary documents to enter the country and will be solely responsible in the event that entry is refused exempting FC BARCELONA.

RULE 8.- ACCEPTANCE OF THE PRIZE.

8.1. The winner, once informed of his/her status as winner, **must give an express response by email**, prior to the delivery of the prize in question, indicating (i) his/her acceptance or (ii) his/her renunciation of the prize, so that:

At the same time, they will send by email a document containing **the express acceptance** of the prize that corresponds to them and their receipt in conformity, declaring that they have nothing to claim or demand from FC BARCELONA.

8.2. c) DATA COMMUNICATION: Your data will not be transferred, sold, rented or made available in any other way to any third party, except Spotify only for the purpose of issuing tickets for the concert subject to the Prize, so FC BARCELONA will share with Spotify, only the data of the winner and, where appropriate, also those of their companion, in case of legal obligation and/or those service providers of FC BARCELONA, who carry out certain actions for the CLUB, but who in no case will process the data for their own purposes. Some of these providers may be located outside the European Union, as indicated below.

d) INTERNATIONAL TRANSFERS: FC BARCELONA, as an entity with an international projection, has international providers that can provide their services from outside the EU, so it is possible that your data may be processed outside the European Union or the European Economic Area (for example, data storage, management of requests for information or member service, etc.).

In any case, the CLUB will ensure that this data processing is always protected with the appropriate guarantees, which may include:

- Standard Clauses approved by the EU.
- Certifications of third parties.

e) DURATION OF PROCESSING: All the information and data you provide us with will be processed in accordance with the provisions of section b) above.

At the end of the indicated period, FC BARCELONA will keep the winner's data and, where appropriate, accompany them duly blocked in order to comply with any legal obligation of the CLUB. The rest of the information obtained will not be used.
