

# CALL FOR ELECTIONS FOR THE BOARD OF DIRECTORS OF FUTBOL CLUB BARCELONA



ELECCIONS  
2026



Under the provisions of Articles 35.4 and 43 of the Club's Statutes, the Board of Directors, as a result of the end of the ordinary term of its mandate, has agreed to call elections for the selection of its members as of July 1, 2026. The voting ceremony will be held on March 15, 2026.

In accordance with Articles 40 to 54 of the Statutes, the election of the members of the FC Barcelona Board of Directors will be in accordance with the following rules:

**1. The following are conditions to be a voter:**

- a. Be of legal age and not be legally incapacitated.
- b. Have been a member for a minimum of one year.
- c. Not have membership status suspended.
- d. Be included in the current electoral roll in accordance with Article 47.

**2. The following are conditions to be a candidate:**

- a. Be of legal age and not be legally incapacitated.
- b. Have been a member at the time elections are called for a minimum of ten years to be elected president and a minimum of five years for the rest of the members of the Board of Directors.
- c. Not have membership status suspended at the time elections are called.
- d. Not have been linked to FC Barcelona as a player, coach, trainer, or employee in the two years prior to the call for elections.
- e. Not have been disciplined by the Club for a very serious infraction within the five years prior to the call for elections.
- f. Have handed in resignation and stepped down before the beginning of Phase VI of the electoral process (submission of nominations for candidacies), in the event that the aspiring candidate is a member of the Board of Directors or of the Management Committee that has called the elections and wishes to stand for re-election.
- g. Be included in the current electoral roll.
- h. Regarding the potential candidate for president: have regional citizenship in Catalonia.

3. On Tuesday, February 10 at 12:00 p.m., the public draw will be held at the Club's registered office to designate the members of the Electoral Board and the Electoral Committee, which will be formed, at the latest, on February 14.

4. From Sunday, February 15 to February 19, members will be able to consult the electoral roll and check the information they deem appropriate through the Club's website. This can also be done in person at the Members' Ombudsman's Office (located in the FC Barcelona Supporter Services Office) between February 16 and 19, from 9 a.m. to 6 p.m.

Complaints for omissions or undue inclusions or rectification of errors must be requested by writing to the Electoral Board and submitted through the roll consultation form, or to the FC Barcelona Supporter Services Office.

The Electoral Board will resolve the complaints that are submitted before the deadline and, at the latest, on February 22, the final electoral roll will be approved, which cannot be modified during the rest of the electoral process.

5. As of Sunday, February 15, aspiring candidates and candidates for president of the Club may write to the Electoral Board to request the official support ballots printed and delivered by the Club. This request can be made in person at the FC Barcelona Supporter Services Office on February 15 from 10 a.m. to 2 p.m. and on the rest of the days during their usual opening hours, from Monday to Friday from 9 a.m. to 6 p.m. Likewise, they may also be requested by writing to the email address [juntaelectoral@fcbarcelona.cat](mailto:juntaelectoral@fcbarcelona.cat).

The Club, in accordance with the provisions of Article 48.3 of the Statutes, will deliver 4,674 official support

ballots free of charge (double the minimum number of ballots that each aspiring candidate must submit) within a maximum period of 36 hours.

6. Until March 2, at 9:00 p.m., nominations for candidacy to become members of the FC Barcelona Board of Directors can be submitted. Candidacies will be presented as closed lists and will be voted on as a whole.

Along with the nomination for candidacy, a minimum of 2,337 official support ballots printed by the Club must be submitted, showing the support of members for the specific candidacy.

The members who sign the official support ballots must be included in the final electoral roll approved by the Electoral Board. Each voter may only support a single potential candidacy.

The official support ballots provided by each applicant must be numbered and ordered by membership number from lowest to highest and must have a handwritten signature on the original copy provided by the Club.

The nominations for candidacy must be made up of a number of candidates not less than fourteen and not more than twenty-one, headed by the candidate for president.

Nominations for candidacy must be addressed to the Electoral Board, in writing and in duplicate, and delivered to the FC Barcelona Supporter Services Office. They must contain the following information:

- List of the names and surnames of the applicants and, together with each name, their handwritten signature accrediting their agreement. Aspiring candidates must meet the conditions established in Article 42 of the Club's Statutes.
- Photocopies of the membership cards of the aspiring candidates and of the identity documents, showing both sides.
- Photocopy of the documentation accrediting regional citizenship in Catalonia of the candidate for president.

The nomination for candidacy shall not include any reference or list of the different positions of the Board, except that of president, which must correspond to the aspiring candidate who heads the list. If the members of the nomination for candidacy deem it appropriate, they may attach a list of the biographical data and merits of the aspiring candidates.

7. The Electoral Board will verify that the members of each candidacy and the signatories of the official support ballots meet the conditions required by the Statutes, and that each candidacy has presented the minimum number of valid official support ballots.

Between March 3 and 5, the Electoral Board will proceed to announce the candidacies that will have the right to participate in the elections once the official support ballots submitted have been checked and verified, provided that the minimum number necessary has been provided.

8. If only one candidacy is presented or remains valid, the Electoral Board will proclaim its members elected and will conclude the electoral process.

9. If several candidacies are announced, the election campaign will begin, which will last from 12:00 a.m. on Friday, March 6 until 11:59 p.m. on March 13.

During the election campaign, candidates may carry out events for information, promotion, or propaganda, as stated and specified in the dossier that FC Barcelona will deliver to each candidate.

The Electoral Board will ensure that in their demonstrations and actions all candidates maintain the respect that opponents deserve and that the principle of equal opportunities in relation to the Club's facilities or services is maintained.

The Members' Ombudsman will send the information and publicity that candidates wish to address to

members, through the services of the FC Barcelona Supporter Services Office.

10. Saturday, March 14 will be the day of reflection. All public activities of the candidacies will be prohibited from 12:00 a.m. on this day and it will not be possible to carry out, either directly or indirectly, actions typical of the election campaign, such as putting up posters, publishing or broadcasting propaganda through the media, making statements, or doing interviews.

11. On Sunday, March 15, voting will be held from 9:00 a.m. to 9:00 p.m. at the following polling stations:

- FC Barcelona facilities;
- Girona, Lleida, Tarragona; and
- Andorra.

The location of the stations outside Barcelona will be made public in due course.

12. Members may vote at any of the polling stations set up by the Club, as the roll is unique and universal.

The tables with the ballot boxes will be organized in alphabetical order so that voters can vote at the table corresponding to the initial of their first surname, without prejudice to the fact that, in the case of a universal roll, they may do so at any of the stations set up on voting day.

13. The voting ballots will be published by the Club with the same format, paper and color for all candidacies.

To exercise the right to vote, members must be registered in the final electoral roll and prove their identity by showing their identity card, driver's license and, in the case of foreigners, passport or NIE (Número de Identidad de Extranjero [Foreigner Identification Number]), all of which must be originals (not photocopies).

The Electoral Committee will preside over and control the voting ceremony, with assistance from the Members' Ombudsman.

14. Once the time for voting on March 15 has ended, the Electoral Committee will arrange for the counting and review of the votes.

The Electoral Board and the Electoral Committee, jointly, will announce the winning candidacy.

15. The newly elected Board must take possession on July 1, 2026, and on that day the members of the previous Board must simultaneously step down.

16. The expiration of the mandate, due to the end of the ordinary term, of the Board of Directors that is elected will take place on June 30, 2031, in accordance with the provisions of Article 34.1 of the Club's Statutes.
